



# The Chronicles of Traditions and Imperial Proclamations

## Preamble

For the establishment of friendship, to support, to advise and to counsel the reigning Monarchs and ICPs.

For the promotion of sibling love and kind feelings.

For the mutual benefit and advancement of the common interests we share within the International Court System.

It is impossible for these Chronicles to contain stipulations for every situation.

These Chronicles have been established to guide our Monarchs and ICPs and counsel them. If not addressed, we will rely on tradition, common sense, good judgment, and practicality in upholding and furthering the goals and objectives of the Imperial Royal Sovereign Court of the Desert Empire, Inc. We have formed a Council of Monarchs (The Council), believing that we can successfully accomplish our objective.

Therefore, incidents that may arise over issues regarding not covered in these Chronicles should be brought to The Council for determination and decision as matter of Chronicle interpretation.

## Section I. Expectations of Reigning Monarchs

- Understand that this is a Business.
  - Have Fun.
  - Do not take these Camp Titles seriously.
  - Raise as much money as you can for the community.
  - Travel to out-of-town events to promote our community.
- Be involved with the International Court Council, keeping abreast of events on that level.
  - Network with local businesses and organizations.
    - Be an integral part of The Council.
    - Support the ICP Council and its events.
  - Insist on support of the ICP's and Ducal Councils on the circuit.
    - Extend leadership capabilities to the Board of Directors.
    - Be the figurehead of our Court to the Community.
- Attend no less than five (5) Out-of-Town Coronations during their reign plus Reno Coronation.
- Attend fund-raising functions, activities in support of the Imperial Royal Sovereign Court of the Desert Empire, Inc. in the Las Vegas area, and if not possible for them to attend, they will be represented by a designated representative of their reign.
- Represent the Imperial Royal Sovereign Court of the Desert Empire, Inc., with honesty and integrity; being fully aware that their conduct can reflect upon the Imperial Royal Sovereign Court of the Desert Empire, Inc., and community.
- Will not misrepresent the Imperial Royal Sovereign Court of the Desert Empire, Inc., community, or their official capacity in any way which could be detrimental to the Imperial Royal Sovereign Court of the Desert Empire, Inc.



- Above anything else, during their reign, both individually and collectively, exercise the utmost effort to maintain and promote the welfare and integrity of the Imperial Royal Sovereign Court of the Desert Empire, Inc. as presented.

## **Section III. Protocol Procedures/Functions**

Out of respect for the International Court System and other like International Organizations, all reigning and past royalty of all organizations will be honored, respected, and announced at all functions. Titles and all announcements will be accepted for recognition prior to the commencement of that function. The word "Most" is reserved for reigning Imperial Family Members and precedes the word Imperial. The word Sovereign is reserved for the reigning Monarchs and precedes the word, "Majesty".

The Titled word "MOST" will be available for use by the members of the reigning Imperial family.

The "social" line of succession will be stipulated by the reigning monarchs but accepted for walk order by all future reigns.

The Titled word "Serene" will be bequeathed on those Monarch's or ICPR's who are deceased.

When the reigning Monarchs are out of town or unable to attend an In-Town function, they must appoint their duly recognized representatives.

## **Section III. Visiting Dignitaries**

All out of town Monarchs will be recognized at Court functions with their titles and full privileges as if they were in their own town.

Any out-of-town titleholder will be recognized at functions provided they produce a letter of introduction from their reigning Monarch(s).

They are to be invited to participate in all of our General Court Meetings and Functions.

## **Section IV. Council of Monarchs**

Any namesake awards must be presented and pass The Council before presentation to the Board of Directors.

Namesake Awards will honor only Monarchs of the IRSCDC, Inc.



Will govern all matters concerning Protocol and may elect to publish a Protocol Manual.

Will meet every odd month or as deemed necessary by The Council. These meetings will be reported to the General Membership as well as the Board of Directors. At Council of Monarch meetings, any decisions made will be based on a 2/3 vote on all attending members and honored by all members of the Council of Monarchs.

Members consist of those individuals elected to the position of Emperor Empress, Emprex or appointed Regent Emperor, Empress, or Emprex. Starting with the Fifth (5th) Reign, Monarchs will be inducted into The Council only after successfully completing their respective reigns and approval voted by the seated members of The Council.

Will conduct with the Board of Directors a mandatory interview for all candidates to the positions of Emperor and Empress and participate in their approval for candidacy to those positions.

## **Section V. Proclamations and Lifetime Titles.**

**Proclamations and Lifetime Titles Defined:** The reigning Monarchs may each make a total of Two (2) Proclamations or Two (2) Lifetime Titles, or One (1) Proclamation and One (1) Lifetime Title during their reign.

The Council shall hear all Proclamations and/or Lifetime Titles for the purpose of interpretation, suggestions and approval. Proclamation(s) that may alter the Corporations governing documents must first be presented and approved with a two-thirds (2/3) vote of The Council, then passed to the Board of Directors to follow the amendments process, prior to being able to take effect.

Proclamation(s) and Lifetime Titles will be recognized by each reign.

The Monarch bequeathing a Lifetime Title is the only person that can rescind or revoke that title.

The reigning monarchs must use their Proclamation(s) or Lifetime Titles prior to the end of their reign or forfeit that privilege.

The Council will enforce and respect the proclamation(s) to the best of its abilities. In the event a past Monarch has no involvement for a period of 5 years with the Organization, their bequeathed Lifetime Title will be recognized at The Council's discretion.

# **Proclamations**

## **Proclamation by Baroness J - Deshannon Christie-Jewel**

~~In the event that the reigning Emperor or Empress should vacate their office for whatever reason, the previous Monarch(s) two (2) years prior, shall fill that office. If that Monarch cannot accept that position, then it would revert to the next previous Monarch(s)...And so on. The position of Emperor or Empress shall never be ruled by one (1) Monarch. If no previous reigning Emperor or Empress is able to accept the position, the BOD shall appoint that vacancy. There will always be a reigning Emperor and Empress. The Monarch that fills that position, shall be known as Regent Emperor or Regent Empress until they complete that reign. Then and only then, will the Regent Monarch be given their permanent title and number.~~

Furthermore, each Monarch will use the word "Crystal" in their title, i.e. "The Strength of the Crystal".

In the event no Monarch is elected or all Monarch Positions become vacant the President of the Board of Directors and the Council of Monarchs shall create a list of qualified, previous Monarchs active in the council and by majority vote of valid votes cast from the council, will fill the vacancy by at least one of the person(s) from the presented list and/or the identified Council of Monarchs as a body representing that year and reign. The person filling an Imperial vacancy shall be deemed as "Regent" with all the responsibilities, duties, and honors as if they were an Elected Monarch. The Monarch that fills that position(s), shall be known as Regent Emperor, Regent Empress, or Regent Emperx until they complete that reign. Then and only then, will the Regent Monarchs be given their permanent title and number.

Furthermore, each Monarch will use the word "Crystal" in their title, i.e. "The Strength of the Crystal..."

The title of Baron and Baroness shall permanently be retired out of respect and in recognition of Baron I, Mark Jensen-Jewel and Baroness I, DeShannon Christie-Jewel. These titles going forward will not and cannot be used within the Court System established in Las Vegas, Nevada.

Furthermore, the lifetime titles previously bestowed, in the Royal Barony of the Desert Empire, are to be transferred and fully recognized in the new IRSCDE with all rights and all privileges.

Proclamation by Emperor VIII – Bryan Cromwell

*Issued July 30, 2007; Revised March 2, 2010*

Preamble: This fund was founded in memory of Imperial Crown Prince 5, Juan Ochoa, whose dedication, and love has remained with many of us since his untimely passing in March of 2003. Juan was a valued member of our organization and the gay community as a whole. At the time of his passing the Court put on the first show to assist in his funeral expenses called “Esperanza”.

Realizing this need existed for other members of our community the Court began this fund. As Juan’s passing brought to light the need for such a fund the members who have been instrumental in its formation thought it would be appropriate to bear his name.

The intention of this fund is to assist with the cost associated with the funeral expenses for members of The Imperial Royal Sovereign Court of the Desert Empire, their families and the community we serve. These protocols are meant to provide guidance for the Emperor and Empress as well as the Board of Directors when a request has been made for help from our organization, as well as provide information to our members and our community to guide them if they need to request our assistance. This fund is not meant to cover the entirety of any one funeral but rather to lend assistance and to ease some of the financial burden. The following protocols are intended as minimum requirements and each request must be examined by the Board of Directors prior to any disbursements.

1. The fund will be kept in an interest-bearing money market account with a minimum of \$2,500.00 (twenty-five hundred dollars) in the fund at all times to keep the account active.
2. Until such time as the fund maintains a balance of \$5,000.00 (Five thousand dollars) no more than \$500.00 (five hundred dollars) may be divested to any single individual per occurrence. At a time when the fund reaches its maintenance goal the Board may revisit the maximum cap per occurrence.
3. A formal written request must be provided to the Board prior to any funds being dispersed stating the intended purpose for the funds, to whom the funds would benefit, to whom the funds will be dispersed, and the amount of funds requested.
4. Proof of death must be provided either through a photocopied official death certificate or public printed obituary.
5. All checks must be written to the funeral home, chapel, florist, travel expense or official funeral services unless otherwise pre-approved by the Board of Directors for special exceptions. These exceptions should only be granted in special circumstances where the expenses are being reimbursed and receipts of payment are provided. Other special circumstances must be handled by the Board.

## **Section VIII: Articles of Traditions**

- Stepping down Empress will crown the newly Elected Empress with all past Empress's contributing a pin to help secure the crown in place.
- White gloves will be worn by all Male line members when attending formal state functions.
- During the annual turnabout show the reigning Emperor and Emperors of The Council will serve the Empresses pizza.
- It is recommended if you cannot attend Reno Coronation to then attend a Brother, Sister or Father Court Coronation.
- In our efforts to promote and bring the hospitality of Las Vegas to other Courts around the International Court System we encourage the conducting of Dam Water fundraising events to be held in their realms supporting their newly elected monarchs. In furthering the promotion of the IRSCDEI it is suggested for each reign to design appropriate T-shirts to wear during these events.
- It is the responsibility of the reigning monarchs to purchase the gifts presented to the stepping down monarchs at those Coronations they attend or send with a Court member attending in their absence. It is also recommended, if they cannot attend a Coronation to send a note of congratulations to the stepping down monarchs.
- To promote the togetherness of the IRSCDEI and to provide the dramatic arrival of any contingent at a Coronation, it is recommended for all in attendance to meet at the Reigning/Latest Empress's room and enter the Coronation Ballroom together.
- To further the hospitality of the IRSCDEI, The Council will take their place outside the ballroom at the IRSCDEI Coronation, at least thirty (30) minutes prior to the start to greet and welcome those guests attending Coronation in a receiving line. The receiving line will go in order from the most senior of monarchs in attendance through the recent.
- There will be a meeting of The Council immediately preceding the Victory Brunch.
- The newly Elected Monarchs are responsible for all regality associated with Coronation until formally turned over to the Dean of the Council.
- In each reign of the IRSCDEI the all family lines will always use a variation of the Star Crown.
- Those who are Aspirant's to the throne of Monarchy will be presented for crowning wearing white, a symbol of humility.
- Stepping down Monarchs are responsible for the cost of all awards which exceed the budgeted amount and are responsible for all gifts given in appreciation of any hosts, commands, or guest to dais.



Those awards which are their responsibility are In-Town plaques or certificates; Coronation Humanitarian, Member of the Year, Crystal (maximum allowed of three), Lifetime & Citizens for Life (as previously defined); Victory Brunch – Title to Title awards, and Coronation theme awards.

- Further it will be The Court's responsibility to fund the President's Award given at Coronation. Additionally, Baron I/Emperor I, Mark Jensen will be afforded the opportunity, at Coronation, if he so chooses to present his MAA (Mark and DeShannon) award and/or on behalf of his deceased Baroness I/Empress I, DeShannon Christie-Jewel the DAA (DeShannon and Mark) award.
- There will be allowed a maximum of five (5) guests each for the stepping down Emperor and Empress to invite onto the dais per set of Coronation, excluding the last set consisting of stepping down presentations and Crowning of the newly elected monarchs where there will be no guest to the dais.
- Monarchs will be the Chairs of Hospitality for Coronation the year following their stepdown.
- Candidate numbers and command performances cannot exceed five (5) minutes in length.
- Anniversary monarchs will be given five (5) minutes each.

### **Section IX. Relinquishing the Reign**

The official transference of power by the Reigning Monarchs to the newly elected Monarchs shall be at Coronation. The stepping down Monarchs must escort the new Monarchs to the stage for the Crowning Ceremony. All symbols of office, including but not limited to: robes, staff/scepter, state crowns, orbs, etc... are to be presented to the newly elected monarchs at that time. The last two official acts of the past Monarchs will be (1) Victory Brunch – Opening and Awards and (2) Divestitures - disbursement of funds raised during their Reign.
